Miscellaneous

The applicant is required to complete sections 1 & 2

The Contact person for the School/Parish is required to complete section 3

The Form must be completed in full using BLOCK CAPITALS and writing must be clear and legible.

The Form should be completed in ball point pen using blue or black ink.

Photocopies will not be accepted.

All applicants will be required to provide documents to validate their identity and Proof of Address If the applicant is under 18 years of age, a completed NVB 3 - Parent\Guardian Consent Form will be required. This is available to download as a separate form www.stsenansed.ie or www.killaloediocese.ie. Please note that where the applicant is under 18 years of age, to the Parent\Guardian. This being the case, the applicant must provide their Parent\Guardian Email address on the NVB 1 form.
