Recent Circulars:

• Circular 0001/2024

This circular outline the details of increased grant funding to be paid to schools to address cost of living increases.

Circular 0004/2024

The purpose of this circular is to make schools aware that in order to increase the availability of retired teachers, the Department of Education has extended the limited

waiver of public sector pensions for a further two years. It is hoped that this measure will assist in addressing the issue of the current shortage of substitute teachers.

• Circular 0005/2024

This circular should be highlighted to teachers who are undertaking further study which are directly related to and relevant to their work as a schoolteacher. The objective of the Teacher Fee Refund Scheme is to provide a partial refund towards the cost of course fees and examination fees upon the successful completion of the teacher professional learning course/s (where the course duration is longer than one year funding is provided upon successful completion of each year of the course).

NCSE Policy Advice Paper

The National Council for Special Education has published its most recent policy advice paper entitled, "An Inclusive Education for an Inclusive Society" which will be of interest to you.

FUNCTION OF ST. SENAN'S EDUCATION OFFICE

In instances where other school stakeholders cannot be advised by school management, the following should apply:

- Teaching staff and other support staff should be directed to their respective unions for any advice they may require.
- Parents should be directed to the National Parents' Council should they require any advice in relation to school processes and procedures.

It has become apparent that some principals are utilising the term as a means to avoid waiting their turn for a reply. We always endeavour to respond immediately to urgent queries. All other queries are dealt with in the order in which they are received, or, in order of importance, depending on the workload of the office staff at the time. Therefore, in the interests of fairness to all who rely on this office for advice and other services, we respectfully request that email or phone queries only be marked as "urgent" where this is genuinely the case. Your co-operation in the above matters is very much appreciated.

NOTIFYING NEW BOARD OF MANAGEMENT MEMBERSHIP TO THE CHARITIES

Under the Charities Act 2009, every board of management must register its school with the Charities Regulator. As part of this registration process, the names, residential addresses and start date of each board of management member must be registered with the Charities Regulator whose website can be accessed at the following link: https://www.charitiesregulator.ie

Further information on the registration process for schools can be found in the following document: Updated-school-registration-guide-final.pdf In light of the recent change of BOM membership, schools will need to log on to the website and input the details of the BOM members who have been elected for the 2023-2027 term.

If any change in board membership occurs during the four-year tenure of the BOM, the details already registered must be amended and updated accordingly.
